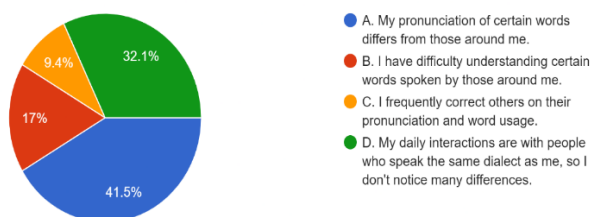
3. METHODOLOGY

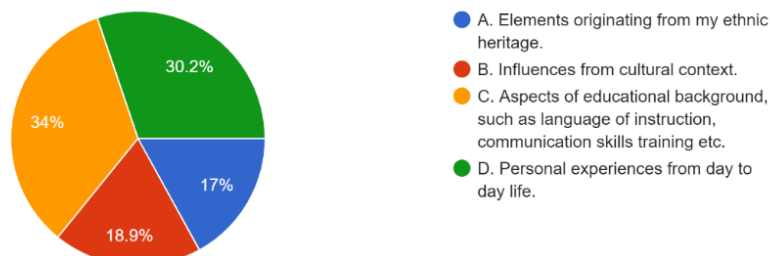

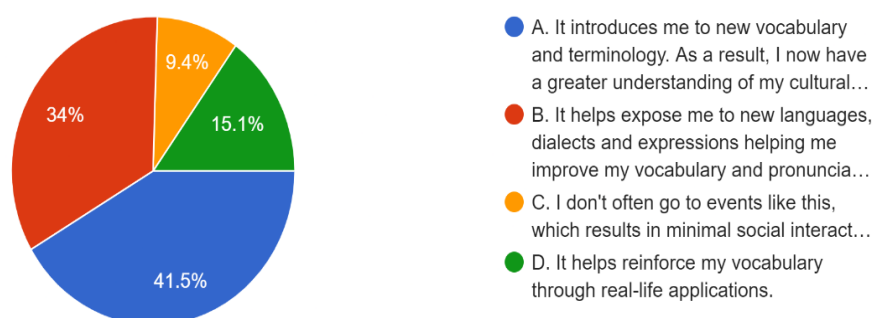

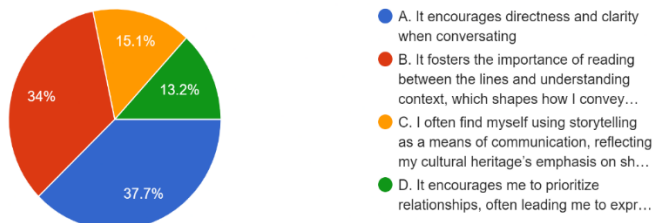

53 responses



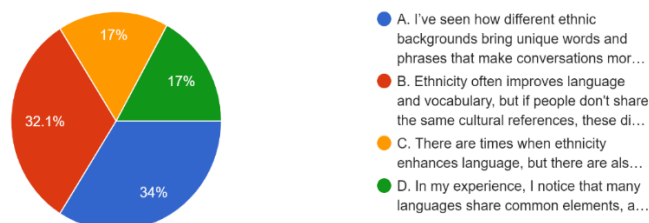

53 responses



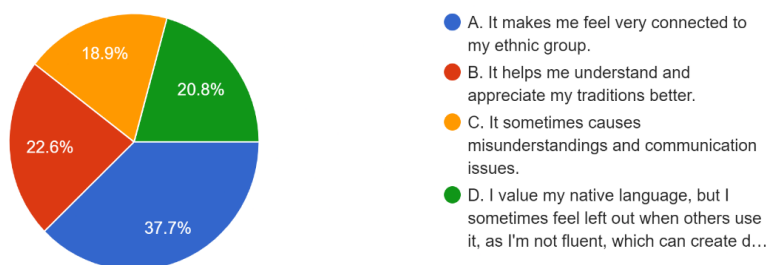
